If I cancel the contract, I personally will not receive a refund. Rather, a refund will be issued to the Beneficiary in order to comply with the intent of the UTMA/UGMA and provide for proper taxing of earnings.		
It is my responsibility to refrain from exercising my rights under the College Illinois! contract in order to maintain the UTMA/UGMA qualified status. The Illinois Student Assistance Commission (ISAC)/College Illinois! will not restrict me or prevent me from exercising these rights.
